JUDGE PRATT

ANSWERS RULE OF FAYETTE COURT AND ARRANGED FOR COMPLIANCE WITH ORDER.

Attorney General Pratt was in the city yesterday in answer to a rule issued by the Fayette Circuit Court against the Insurance Commissioner and the State Treasurer to show cause why they should pay into court certain securities belonging to the defunct American Life Insurance Company to satisfy a claim of Mr. J. A. Edge.

Some time ago Emily Cole obtained a judgment for \$300 against the American Company, which had sold out to the Metropolitan Life, of New York. The judgment was assigned to Mr. Edge, who thereupon moved that court for a rule requiring the State officials to turn over certain securities to reimburse Mr. Edge. Judge Pratt in company with Mr. Edge, and was introduced to a number of officials. He expressed himself as much pleased with the beautiful Fayette temple of justice.

WASHINGTON, Dec. 1.—(Associated Press).—Rear Admiral Higgins called the Navy Department, under date of San Juan, December 1, as follows: "The Panther is ordered to Hampton Roads on account of malaria fever and debilitation of marines. Their condition is not considered serious." "Naturally apprehension is felt as to the condition of marines who have been on the Isthmus more than a month, guarding the Panama Railroad. After this duty was over it was desired that the marines participate in the defense of Culebra Island during the winter maneuvers, and they were dispatched there. At the Navy Department there is to be no reason for alarm over Admiral Higgins' dispatch.

ANNUAL BANQUET

IN CELEBRATION OF ST. ANDREW'S DAY A NOTABLE FUNCTION.

The Caledonian Society of Lexington held its annual celebration and banquet last night at the Leland Hotel in honor of St. Andrew's day. About fifty guests were seated at the long tables and celebrated in truly loyal and enthusiastic manner the day of the patron saint of their native land.

Rev. Andrew Meldrum, of Kentucky University, invoked divine blessing, giving the famous verse from Robert Burns, the peasant poet of Scotland: "Some has meat and canna eat, And some will eat that want it, But we hae meat and we can eat, So let the Lord be thankit!"

The following excellent menu was then served: Oyster soup, salted almonds, olives, pickles, baked blue fish creole, Long Branch potatoes, braised sweetbread on toast, mushroom sauce, roast young turkey with dressing, cranberry sauce, celery, broiled quail on toast, French peas, frozen imperial punch, chocolate ice cream and cake, coffee, cigars.

After the tables had been cleared, President Copland announced the toasts, to which the various gentlemen responded. The toasts were drunk heartily in the Scotchman's favorite drink, "Hot Scotch."

Rev. Alex. Patterson, the pastor of the Episcopal Church at Beattyville, responded very appropriately to the toast, "St. Andrew, Scotland's Patron Saint." He spoke of St. Andrew's life, the chance that brought St. Andrew's remains to Scotland and the wonderful influence that such a chance event had upon the subsequent history of civilization.

Prof. A. Saint Clair Mackenzie, of Kentucky State College, then sang two of Scotland's ballads, "The Blue Bells of Scotland" and "Bonnie Wood of Craigielea." Prof. Robert L. Blanton was called on by the toastmaster and recited, much to the delight of the party, "The Ordination of Brother Johnson."

President James K. Patterson eloquently responded to the toast, "The Union Jack," and his remarks were frequently interrupted by applause. He spoke of the influence of the spirit of the Anglo-Saxon race, symbolized by the Union Jack, on the institutions and jurisprudence of civilization through Magna Charta and the Declaration of Rights; its influence on the literature of the world; its influence on the material prosperity of civilization; and its influence in war, a battle of which, he said, had been fought in the last two hundred years for the cause of freedom, where the Union Jack has not covered those who were struggling for liberty. In closing, he said: "The day will soon come, and is not far distant, when the forces under the Union Jack and the force under the Stars and Stripes, combined with the forces of that magnificent little nation on the shores of the Pacific, that has made so much progress in the last fifty years, the forces of Japan, will unite to rule the world."

ST. PAUL, Minn., Dec. 1.—(Associated Press).—A rate war is on between the Chicago lines over the division of business arising from the large movement of discharged soldiers from Northwestern army posts to the East. Perhaps one thousand soldiers are moving this week.

THE Chicago-St. Paul lines made an agreement to charge \$3.05 from St. Paul to Chicago. Today the Great Western announced its withdrawal from the agreement and a rate of \$7. A meeting of the other lines was called and the probable result will be a joint agent of the six lines, authorized to meet any rate made by the Great Western.

CASE AGAINST PACKERS RESUMED. KA'SAS CITY, Mo., Dec. 1.—(Associated Press).—The case against the packing houses for alleged infraction of the Missouri anti-trust law began again in various packing centers throughout the State at intervals for the past three months, came up for a second hearing today.

The hearing was conducted before Judge J. A. Kintner, Special Commissioner. The State closed its case three weeks ago and the record began the introduction of testimony today. The testimony introduced today indicates that the defense will try to prove that a conspiracy does not exist as charged and that the high prices cited by the State are due to the law of supply and demand, increased scarcity of feed and fat cattle and other national causes. The hearing will be resumed tomorrow.

DURBIN AND PARTY FIND RAIN IN TEXAS. CORPUS, TEXAS, Dec. 1.—(Associated Press).—Governor Durbin and a party of five officials have arrived at Gull Hollow, a hunting resort near here and established camp. It has rained continually since their arrival, and they have not been able to get at ducks and geese.

The toast, "The Stars and Stripes," was responded to by Maj. D. G. ASIA

IS TAKING KEEN INTEREST IN WORLD'S FAIR.

WASHINGTON, Dec. 1.—(Associated Press).—According to mail advices from the East, John Barrett, commissioner general to Asia and Australia for the St. Louis Exposition, is meeting with considerable success in his efforts to interest the Asiatic countries in the exposition.

His reports indicate that these countries will have a larger and more interesting display than they have ever made at preceding expositions. Mr. Barrett spent some time at Manila, where, in spite of the depressed financial condition and the competition of other expositions, he secured assurance of a comprehensive Philippine exhibit. Hawaii, Japan, Korea, eastern Siberia and China have pledged themselves to make creditable exhibits at the fair. Word has been received by Mr. Barrett from Siam, India and Ceylon that they will rival the other Asiatic countries in their exhibits.

ADDER

WASHINGTON, Dec. 1.—(Associated Press).—The board of naval officers appointed to conduct the trials of the new torpedo boat Adder and Moccasin, today submitted their report on the Adder and recommended the acceptance of that vessel after certain defects and unfinished work are completed satisfactorily. The board calls attention to the fact, however, that "although the trials to which the Adder has been subjected fulfill the strict letter of the contract under which this vessel was built, yet they do not provide for any trial under service conditions at sea, and on account of the extremely novel character of the vessel it is impossible to predict from her performance in the smooth waters of a landlocked harbor an opinion as to her behavior in a model seaway."

ALMOST TO POLE

SHIP WAS CARRIED BY ICEBERGS. PERILOUS VOYAGE AND REMARKABLE ESCAPE.

ST. LOUIS, Mo., Dec. 1.—(Associated Press).—Wilson R. Mizner, a brother of Rev. W. Mizner, pastor of St. Stephens House, Episcopal Mission of this city, returned from an involuntary and perilous trip to the arctic regions, in a case of wretchedly moving icebergs reached a point as near or nearer to the North Pole than had been attained by professional explorers.

Mizner was gone six years. He relates a most thrilling tale of a remarkable voyage within six hundred miles of the goal of all arctic expeditions. The party was on its way from Seattle to Cape Nome, and had almost reached its destination when hurried from its course by icebergs and carried away in a northerly direction to a point several miles north of Herald Island, the icebergs were scattered in the Pacific Ocean. All efforts to rescue the ship from her perilous position in the bergs were futile.

His witness account of the perils and experiences of the trip with icebergs to within six hundred miles of the Pole is detailed in full. A safe return to the north helped the ship to escape. The captain took advantage of a split in a berg to ram his vessel through the cracks. The vessel on which Mizner sailed was the Portland.

FIRST DECISION IN A CASE COMING FROM HAWAIIAN COURT.

WASHINGTON, Dec. 1.—(Associated Press).—The Supreme Court today decided the first opinion ever rendered by it in a case coming up from a Hawaiian court. The case was that of the Equitable Life Assurance Society of the United States against Cecil Brown, administrator of the estate of Thomas E. Smith. Mr. Smith was domiciled in Hawaii, and while there took out a life insurance policy. He afterward died in San Francisco. Administrators were appointed in Hawaii and in New York, the latter appointment being made at the instance of relatives in this country. The insurance company refused to pay the policy to the Hawaiian administrator; he sued on that point. The court decided the writ on the ground that no Federal question is involved.

UNSATISFACTORY CONDITIONS IN HAVANA.

WASHINGTON, Dec. 1.—(Associated Press).—Unsatistactory reports have come to the State Department in regard to the sanitary condition in Havana. General Wood's reports for 1899 and 1900 show that the Cuban city was exceedingly healthy as a result of the American methods of sanitation enforced. The State Department is advised that a relaxation of this system is taking place gradually but surely. The sanitary inspectors are said to be more lenient and there are numerous violations of sanitary laws.
